## Senate Bill 66

*Introduced by: Senator Carley*

- 1    **An Act to prohibit the use of automatic tabulating equipment and electronic ballot marking systems.**
- 2
- 3    BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:
- 4    **Section 1. That a NEW SECTION be added to chapter 12-1:**
  - 5        The State Board of Elections may not authorize the use of any automatic tabulating
  - 6        equipment or electronic ballot marking system.
  - 7        The governing body of a political subdivision having supervision of an election may
  - 8        not adopt, implement, or use any automatic tabulating or electronic ballot marking system
  - 9        in an election.
- 10      **Section 2. That § 12-16-2 be AMENDED:**

### **12-20-13.1. Means of counting provisional ballots--Appointment of officials.**

The person in charge of the election shall decide if the provisional ballots are to be counted by hand or by automated tabulating equipment. If the decision is made to count the ballots by hand, a provisional ballot counting board shall be appointed as provided in § 12-15-1. If the provisional ballots are to be counted by automated tabulating equipment, a resolution board and tabulation machine operators shall be appointed as provided in chapter 12-17B.

14 **Section 12. That § 12-17B-2 be REPEALED.**

15 Any automatic tabulating or electronic ballot marking system used in an election  
16 shall enable the voter to cast a vote for all offices and on all measures on which the voter  
17 is entitled to vote. No automatic tabulating, electronic ballot marking, or election voting  
18 equipment system may be connected to the internet. No ballot marking device may save  
19 or tabulate votes marked on any system. Each system shall fulfill the requirements for  
20 election assistance commission standards certification and be approved by the State Board  
21 of Elections prior to distribution and use in this state. No system may be approved unless  
22 the system fulfills the requirements as established by the State Board of Elections. Any  
23 changes or modifications to an approved system shall be approved by the State Board of  
24 Elections prior to distribution and use.

25 **Section 13. That § 12-17B-3 be REPEALED.**

26 Any governing body having supervision of elections within any political subdivision  
27 may adopt, experiment with, or abandon any automatic tabulating or electronic ballot  
28 marking system approved for use by the State Board of Elections. Any governing body  
29 may use the system in all or some of the precincts within its jurisdiction or in combination  
30 with any other type of voting system approved for use by the State Board of Elections.

# HAND COUNTING STATS

- A. Germany, Norway, Netherlands, France, Denmark, Italy, UK, Ireland, Spain, Portugal, Sweeden, Finland
- B. Canada's federal elections
- C. Instead of finishing 10 hrs later at 6am in the morning at two of the largest counties in 2024's election, hand counting can finish in 2-4 hours afterwards

# 6. WE'LL SAVE MILLIONS OF DOLLARS

Machines, software, maintenance agreement, certifications, virus updates, personnel to manage all are costing our taxpayers more than it needs to

# MACHINES VS. HAND COUNTING COSTS

- Each county will spend 20% of the current costs for elections switching to hand counting
- Examples:  
LOCAL: \$60,000 spend with ES&S with 18,000 ballots....that's ~\$3.35 per ballot  
STATE: \$1,700,000 spent with ES&S with 500,000 ballots....that's ~\$3.35 per ballot

COMPARED TO: \$600,000 hand counted cost = \$1 per ballot

WOULD SAVE SOUTH DAKOTA OVER \$1.1m PER YEAR

### **12-20-1. Delivery of supplies to **counting** board--Certificate of transmittal and receipt--Commencement of **count**--Continuation without adjournment--Comparison and correction of poll lists--Penalty.**

As soon as the polls are closed, the precinct superintendent and precinct deputies shall audit the ballot **count** as prescribed in §§ [12-20-2](#) and [12-20-3](#). The precinct superintendent and precinct deputies shall then immediately deliver the ballot boxes, registration book, pollbook, and other election supplies, including voided and unused ballots, to the **counting** board, if appointed, and sign a certificate of transmittal and receipt as prescribed by the State Board of Elections. The members of the precinct election board or the **counting** board, if appointed, shall then immediately proceed to **count** publicly, in the presence of all persons desiring to attend the **count**, the votes received at the polls, and continue without leaving the site of the **count** until the **count** is completed. A person charged with implementing this section may not delay the **counting** of ballots other than to authorize short recesses for the health and wellbeing of those employed to implement this section. In **counting** the votes, the members of the precinct election board or **counting** board shall use the tally sheets provided.

## SOME CITIZENS HAVE HAVE ASKED FOR COUNTIES FOR HAND COUNTS


1. Taxpayer funded attorneys have fought them back

# FAQ'S

- A. Doesn't this violate ADA?  
*NO, disabled people voted before machines were around and can if they are gone. Federal/State law allows someone to help them on site. Law requires accessibility NOT electronic equipment.*
- B. We have post election audits, so why do we need this?  
*5% post election audits is not robust enough to catch anomalies or errors. Would the IRS accept an audit of 1 day of your receipts as acceptable?*
- C. A small test was done in one county of hand vs. machines and they were equal?  
*Machines are capable of counting correctly if programmed correctly, however, one line of code can be changed at any point in time or a bug, making all races at all time susceptible to manipulation.*
- D. Why does the SOS not support this if it's a good idea?  
*The Secretary is there to simply follow and implement laws made by the legislature. The legislature represents and gains its consent from the governed. The people are here today requesting their power back.*
- E. Why do some county auditors not support this if it is a good idea?  
*Some County auditors appear to be under the impression it will be more work for them. However, they currently do ALL the work, counting all the ballots at the courthouse sometimes until the next day. The work would actually fall back to the people of the precinct, and the county parties to staff and count the elections. All the auditors have to do is report the results.*

# VOTING MACHINES

VOTING MACHINES BY DEFINITION OF THE EAC AND HAVA : “voting machines” means any electronic or automated device that casts, records, interprets, counts, tabulates, aggregates, or reports votes, including but not limited to:-

- Electronic vote tabulators, including optical-scan ballot scanners that electronically count or tally votes
- Ballot Marking Devices (BMDs) that electronically record voter selections prior to producing a ballot
- Direct Recording Electronic (DRE) voting machines, with or without a paper record
- Precinct or central-count tabulation devices that electronically aggregate vote totals
- Electronic vote-counting or result-aggregation systems used at any stage of tabulation or reporting
