ANALAYSIS OF MINNEHAHA COUNTY, SOUTH DAKOTA NOVEMBER 2020 CVR JEFF O'DONNELL 5/13/2024

GENERAL

The Cast Vote Record file contains a record of 93,430 ballots. I was unable to find a web page showing the official number of ballots received in the 2020 General election, however a total of 92,326 presidential votes are reported by Wikipedia¹ and the Cast Vote Record shows the following.

Removing the 49 overvotes and 1,055 undervotes results in 92,326 votes, which matches the total above. In addition, the candidate totals from the Wikipedia page match the totals in the Cast Vote Record. Therefore, I deem the CVR complete with no redactions.

The breakdown of in-person vs. mail-ins listed above has been inferred from the data and may differ by +/- 50 votes. If mail-in totals are available from the county or state, they should be compared with the numbers above.

TEST FOR MESA PATTERN

As described in detail in my "Fingerprints of Fraud" report², the "Mesa Pattern" is an unnatural pattern of partisan voting observed in votes from mail-in ballots which show a random pattern of receipt. As such, the cumulative percentages throughout the counting should show a general conformance towards the final value with the rate of change also steadily decreasing.


The three criteria of the Mesa pattern are:

- 1. The cumulative percent of the "tested candidate" (in our example, President Trump) hits a low within the first 40% of the counting of Mail-in ballots, and after that point the cumulative percentage never falls below that point.
- 2. The graph of the cumulative percentage of the tested candidate generally rises upward from that point, with a possible "correction" seen.
- 3. The tested candidate's final percentage of the vote is 1.1x to 1.3x the percentage at the exact middle point of the vote.

The following graph shows President Trump's cumulative percentage throughout the counting of the mail-in ballots, using a block size of 500 votes. The numbers at the bottom are the number of mail-in votes counted between the two candidates at that point. The numbers on the left are the percent of the mail-in votes which President Trump was credited with at that point.



This graph shows that Minnehaha County satisfies all three of the Mesa Pattern criteria. President Trump hits a low point of 28.3% very early in the counting, and his percentage never drops below that again. The gradual rise is obvious from that point, with an apparent correction at the end (the dipping down of the percentage starting at 33,300 votes). Please note that votes at the end may include the counting of provisional ballots. Finally, the percentage reported for President Trump at the end of the counting of mail-in votes (40.7%) is 1.115x the percentage reported at the halfway point (36.5%).

The red lines indicate what we would expect to be the highest and lowest possible percentage at the given number of votes counted if the mail-in ballots are mostly random and unmanipulated (given the final percentage). These lines are used as a general guideline to spot results which differ greatly from what is expected. In Minnehaha County, it is evident that there are a lot more Biden votes (or a lot less Trump votes) than we should see.


Examining the ratio of votes for President Trump in each consecutive 100 ballot block demonstrates the general upward movement, rather than a random "cliff and valley" look.



It is remarkable that after 11,000 votes President Trump had no further 500 vote blocks under 36.5%, and after 25,000 votes never had a block under 40% until the "correction" at the end. This is the typical gradual pattern seen in the other counties.

The Senate race between Mike Rounds and Dan Ahlers also shows a very similar pattern. Interestingly, of the contested State Senate races, Districts 9 and 15 show a Mesa pattern in their mail-in votes, while Districts D11, D13 and D14 do not.

Large precincts (of 2,000 voters or more) can also show unusual patterns, and within a precinct there can be an expectation of fairly random participation by the voters on election day. In precinct VP02, despite the trend towards President Trump referenced above, the cumulative percentage of Trump votes actually dropped 13% between the middle of the counting to the end. This would imply that on election day Democrats waited and voted later in the day than Republicans (in general). Records of the VP02 precinct might cast some light on that if they still exist. The following chart shows the Trump percentage over the course of the counting. Please note that only about 20 votes at the tail end were mail-in votes.




From all of the above findings, Minnehaha County joins over 180 other counties across the country in which I have observed the unnatural Mesa Pattern, showing that a software algorithm was used to manipulate vote data.

REVERSED ELECTION ANALYSIS

Another analysis that I perform is less scientific but has proven to yield very consistent results among Mesa pattern counties. If I make the assumption, based upon my research, that the mail-in votes at the *end portion* of the counting are more valid than votes at the *start portion*, viewing the count in reverse should give an idea of what the organic vote might have looked like. Of course, the caveat is that my research into the Mesa County, Colorado and Maricopa County, Arizona election servers does show a constant manipulation, however the bulk of that manipulation does appear to be in the first half of the mail-in counting.

Viewing the same graph as the one above but in reverse shows this interesting pattern.



As we are viewing the data in reverse, it can be seen that the percentage of the vote credited to President Trump seems to be trying to stabilize at around 44% until about the halfway point, when it begins a steady decline. 44% is 3.4% higher than the reported final percentage of 40.6%. If one theorizes that the 44% is the minimum actual mail-in vote percentage for President Trump, this will mean that manipulation caused a minimum 1,248 votes "missing" for him (or the same amount added to Biden's totals). If this happened as the result of switched votes, it would mean an actual swing of 6.8% in favor of Biden. That number is important because it falls in line with many of the other Mesa pattern counties (6 to 10%). This is a benchmark which attempts to estimate the minimum impact of the manipulation seen in the county.

VOTER DEFECTION ANALYSIS

My research, which has analyzed millions of votes in recent elections, has found that an average of about 4-6% of voters split their ticket, i.e. do not vote for all candidates of one declared party. Between federal and state candidates this number is even less. Thus, when it is observed that significantly more voters "defected" from their party, it could be an indication of votes being manipulated. I refer to a voter who votes for candidate 'A' in one party and candidate 'B' from the other party as a "Defector", especially when dealing with the top-level races.

In Minnehaha, there are a great deal of defections as recorded in the Cast Vote Record. 52,773 voters voted for Republican Mike Rounds for Senator (which is in and of itself surprising, being 12,291 votes higher than President Trump's total). The Cast Vote Record allows us to dig deeper, showing that of those 52,773 voters, 6,191 (11.7%) voted for someone other than President Trump, while 2,865 (5.4%) voted for Biden. Please note that undervotes (where there was no selection) are not included in these calculations.

Likewise, Republican Gary Hanson received 55,108 votes for Public Utilities Commissioner (2,335 more than received by Senator Rounds and 5,859 more then President Trump). Of those voters, 10,802 (19.8%) did not vote for President Trump and 8,907 (16.2%) did not vote for Senator Rounds.

This pattern continues among the Republican candidates, and in total 15.2% of voters who voted for a Republican Candidate voted for someone other than President Trump (6.5% voted for Biden), and 11.2% voted for someone other than Senator Rounds (6.2% voted for Democrat Dan Ahlers).

The possible conclusion I reach from this is that an algorithm that re-ordered and changed votes created inconsistencies in individual ballots, and those inconsistencies are uncovered by the Voter Defection Analysis. Local analysis of the candidates and their support bases, platforms, and advertising is encouraged.
