The State of North Dakota intends to purchase a product that does not have a known match. This notice is an attempt to identify possible alternatives. # Requestor: Secretary of State, Elections

**Purchase Description:** The North Dakota Secretary of State intends to accept, at no cost to the state, election management system software from the State of South Dakota. This software was created for the South Dakota Secretary of State's office utilizing federal dollars allocated to the state through the Help America Vote Act of 2002. The South Dakota Secretary of State believes the citizens of the United States funded the creation of the software and therefore the State of South Dakota will not seek monetary gain from other jurisdictions desiring its use.

The election management system unifies separate election systems allowing a single point of entry for all common data, establishes standardized formats for data transfer, and provides a relational election results database for every contest in any election held within the state of North Dakota. The results database will be accessible to the public from the Secretary of State's and any North Dakota county website. The system will be hosted in the North Dakota State Data Center, it will be securely accessed for election administration by the state and the 53 counties, it will transfer all necessary data to a chosen election services vendor (selected under a separate contract executed in 2004) for ballot layout and voting machine programming, it will provide rapid transfer of election results to the public, and it will provide data exports to the media and public that have not previously been possible in North Dakota.

**Intended Source:** The South Dakota Secretary of State will provide the software. The necessary customizations for its use in North Dakota will be provided by BPro, Inc. 318 S Pierre St, Pierre SD 57501. This firm created the software and retains the proprietary rights for providing additional enhancements.

**Price:** The software will be provided at no cost by the South Dakota Secretary of State. Necessary enhancements will be purchased from BPro, Inc. based on a time and materials contract. The cost of the customization services is estimated at approximately \$100,000. The contract with BPro, Inc. may include a provision for ongoing support.

**Justification:** This software is available exclusively from the South Dakota Secretary of State and BPro, Inc. has the exclusive rights to enhance or customize the software for use in any other jurisdiction. The current features list for the software is attached.

# Software Feature List

### Overall
