## **COUNTY INITIATIVE PETITION**

WE, THE UNDERSIGNED qualified voters of XXXXXXXCounty in the state of South Dakota, petition that the following ordinance be submitted to the voters of that county for their approval or rejection pursuant to law.

The proposed ordinance in proper form is as follows:

## AN ORDINANCE DEFINING THE CONDUCT OF ELECTIONS WITHIN XXXXX COUNTY

BE IT ORDAINED by the Board of County Commissioners of XXXXXXX County that the following rules regarding elections in XXXXXXX County, are hereby adopted:

From the effective date of this ordinance, elections in XXXXXXX County shall be held at times and places as required by SDCL 12-2 and this ordinance.

- 1. All elections in XXXXXXX County shall be conducted by paper ballot only.
- 2. Tabulation of votes shall be by hand count after polls are closed in accordance with SDCL 12-20.
- 3. Electronic voting devices, of any kind, are prohibited with the exception of devices for those with disabilities.
- 4. Electronic tabulation devices, of any kind, are prohibited.
- 5. Absentee ballots properly obtained and marked by the individual voter in accordance with SDCL 12-19 shall be tabulated by hand after polls close. Ballots received after 7pm on election day shall be disqualified.

## **INSTRUCTIONS TO SIGNERS:**

- 1. Signers of this petition must individually sign their names in the form in which they are registered to vote or as they usually sign their names.
- 2. Before the petition is filed, each signer or the circulator must add the residence address of the signer and the date of signing. If the signer is a resident of a second or third class municipality, a post office box may be used for the residence address.
- 3. Before the petition is filed, each signer or the circulator must print the name of the signer in the space provided and add the county of voter registration.
  - 4. Abbreviations of common usage may be used. Ditto marks may not be used.

5. Failure to provide all information requested may invalidate the signature.
